Aengus O'Rourke agreed to progress the issue in the broad interests of the town. In January 2011 Athlone Town Council agreed to a motion by Cllr. Aengus O'Rourke to provide money to clean part of the canal in cooperation with other private / public bodies.

In June 2011 a group of like minded local people came together to develop a plan to restore the entire canal. This is obviously a very ambitious plan and one that would cost unimaginable sums of money, particularly given the economic climate. However, taken over time (like all canal restoration projects) and in manageable time frames, it is possible to turn our redundant canal into a wonderful outdoor amenity for everyone to enjoy now and for generations to come.

The Athlone Canal Group are delighted that the Athlone branch of the IWAI are involved and supporting their efforts and will in fact play a major role in bringing together the various component parts that make up a viable canal restoration project.




#### Sean Fitzsimons RIP by Damien Delany

It was with shock and great sadness that we learned of the death of Sean Fitzsimons on the 16th July. Warm tributes were paid to Sean from a variety of organisations with which he was associated, Athlone Vintners Association; Athlone Boat Club; Athlone Sub Aqua Club; RNLI; Aware; and in particular The Inland Waterways Association of Ireland.

Sean had a deep and abiding love for the River Shannon, and indeed for all of the waterways of Ireland. He supported and attended cruises & rallies on most of them over many years, and despite being quite ill in recent years he always made an effort to travel to various events, and to attend branch meetings – always with a "to do" list.

Sean, born & reared in Dublin, fell in love with the Shannon in 1961 when he and some friends hired the barge St. Mary to take



In 2010 when President Mary McAleese officially opened the 50th Shannon Boat Rally in Carrick on Shannon, Sean was feted as the only person to have attended all 50 rallies.

The "Lung" was always the "party boat" wherever it went, always music & craic, and inevitably the strains of Carrickfergus, as only Sean could sing it, could be heard into the wee small hours.

In his early years he worked as a church furniture & fittings salesman with Gills of O'Connell St. Dublin. He bought Sean's Bar in Athlone in the late 1960's, retired from the church supplies business and became a fulltime publican, running Sean's Bar with his friend Dermot O'Brien. In addition to running the pub, they both found the time to attend rallies all over the country, north & south.

Sean was a member of Athlone Branch IWAI and we were fortunate to have him as Treasurer for over 30 years. He had the knack of persuading people to join the IWAI, and up to the present time, Athlone branch have members all over Ireland; in the UK; USA; Germany; Holland; and West Indies, all of whom were tourists, recruited by Sean in the pub.

He was largely responsible for building and maintaining our membership numbers, and a healthy bank balance, which contributed to branch activities over many years such as providing mooring buoys & jetties at Athlone town, Ballykeeran, Portrunny, and Lecarrow.

He organised the reprint, sale and distribution of Harry Rice's book "Thanks for the Memory" in 1974 which built a healthy Development fund for the various branch projects and also for the benefit of various other organisations such as Athlone Sub-Aqua Club, Athlone Boat Club, RCAG, etc.

He also organised the more recent reprint, sale and distribution of "Thanks for the Memory" in 2002, which benefited the Dunrovin Trust redevelopment fund.

He also has organised and sold reprints of old charts (1808) of Lough Ree & Lough Derg which were found in Dunrovin, which also benefited the Dunrovin Trust fund.

Sean also organised the reprint of LTC Rolt's book "Green and Silver" which raised over £10000 for the Royal Canal Amenity Group restoration projects.

He was the Chairman of the Athlone RNLI fund raising branch and organised flag days & other fundraisers every year. He acted as "Auctioneer" at the Shannon Boat Rally RNLI Auction which raised sums ranging from €5,000 to €10,000 each year for the lifeboats. He was instrumental in having the original plans for the development of the west side quay at Athlone drawn up by architect Noel Murphy and also the original plans for the Athlone Town Marina, also by Noel Murphy, and for promoting these developments with Athlone UDC.

Truly a remarkable contribution to the common good that anyone would be proud of, but Sean took it all in his stride, his mind never stopped thinking of ways to raise funds; to get things done; to improve the facilities.

Alas, in his 81st year, the handsome boatman has come to ferry him over and to lay him down. Members of Athlone Branch IWAI and Athlone Boat Club formed a guard of Honour at Sean's removal to the Church of Saints Peter & Paul in Athlone, where he arrived to the moving strains of Carrickfergus, courtesy of the Henshaw family.

We extend our deepest sympathy to Anne, his nephews, nieces, relatives and a wide circle of friends. May he rest in peace.





#### Kerry Sloane RIP by Keith Rowe

August saw the sad passing of a well known figure to the boating community in the Athlone area. Kerry Sloane passed away after a short illness at the age of 81. Kerry led a full, varied, and interesting life, serving with the Irish army and also establishing one of the first boat hire companies on the Shannon in the early seventies. Although his army career was long and illustrious, serving in the Congo and Cyprus, many of us will remember him from his time as owner of the Athlone Cruisers boat hire company and the Jolly Mariner bar/restaurant marina. Kerry also owned the Rosebank Marina in Carrick on Shannon from where he operated the Flagline boat hire company for a period.

Over many years, Kerry worked tirelessly to build his business and to contribute to the economic and tourism life of Athlone. He had a very strong sense of community, being deeply involved with Westmeath Tourism, Midlands East Regional Tourism Authority (MERTA Westmeath Community Development Athlone Chamber and the Rotary Club of Athlone. and many other organisations large and small, to whom he gave his time, energy and expertise without question. A former Army officer and a successful businessman, he gave much of his time and energy to the promotion and tourism development of Atjhlone, tyhe river Shannon and lakes of Westmeath and the Midlands. Kerry was also very supportive of the activities of boaters on the Shannon through the years, lending his cruisers to the rowing club for their regattas, providing cruisers to the Lough Ree Yacht Club, hosting IWAI Athlone branch meetings in the seventies and eighties, the Peoples regattas and festivals in the nineties and the Shannon Rally on occasion. In fact one of Kerry's cruisers won the Premier award on the Shannon Rally (Noel Maitland skipper) in recent years.

My own memory of Kerry is from a time when I worked for him as a schoolboy on summer holidays alongside him and my father and I remember him as an incredibly hard working many who never saw problems as something that could defeat you but rather as solutions waiting to be found. We extend our deepest sympathy to Maura, his wife and sons Diarmuid and Niall and his daughter Emer, sisters Eva and Nuala, grandchildren and all his relatives and a wide circle of friends. May he rest in peace.

# Shannon Catchment-based Flood Risk Assessment and Management (CFRAM) Study

The Shannon CFRAM Study (one of seven in Ireland) will focus on areas known to have experienced flooding in the past or are subject to significant development pressure now or in the future. Historically, flood risk in Ireland has been addressed through the use of structural or engineered solutions to existing problems, for example through the implementation of flood relief schemes to protect towns or areas already at risk. In line with internationally changing perspectives, the emphasis in addressing flood risk has now shifted towards:

- A catchment-based approach,
- More pro-active risk management, with a view to avoiding or minimising future increases in risk,
- Exploring the use of more 'non-structural' solutions as well as traditional engineering measures.
  The Shannon Study area is divided up into five Units of Management (UoM) based on the hydrological characteristics of the area.

#### The following outputs will be generated for each UoM:

- Detailed flood maps that show where current and future flooding is likely to occur (to be produced by December 2013).
- An indication of the options they have for managing and mitigating that flood risk.
- Flood Risk Management Plans (FRMPs) setting out how the OPW, local authorities, stakeholders and communities should work together to take actions that address specific local flood risks (to be produced by December 2015).
   The FRMPs are subject to a Strategic Environmental Assessment (SEA) in order to:
- Provide for a high level of protection of the environment;
- Understand local community and social considerations; and,
- Promote sustainable development by integrating environmental considerations into the preparation and adoption of specified Plans and Programmes.

#### The SEA process can be defined by four key stages:

- Stage 1 Screening of Plans and Programmes
- Stage 2 Scoping the SEA
- Stage 3 Identification, Prediction, Evaluation & Mitigation of Potential Impacts (Environmental Report)
- Stage 4 Consultation, Revision and Post-Adoption
- They are currently at stage 2 in the process.
