#### **CHAIRMANS REPORT IWAI ATHLONE BR, 1998**

On behalf of the members of the Athlone Br. of IWAI I wish to thank our President, Mr. Liam Darcy, his committee, and the Council members for their assistance and guidance over the past year.

I wish to thank and congratulate all members of the various committees involved through out the year. On behalf on myself and our members, I wish to congratulate and thanks Mrs. Eileen O'Brien who has worked tirelessly over the years unaided producing your Aerial,

#### Branch Matters.

The branch committee had a fruitful year working on your behalf on matters relating from, Rallies, Planning, water pollution, and discussing various Government documents pertaining to our waterways. etc.

The Br. Executive constantly keep themselves appraised of the various Co. Co. planning and future developments within our area. We have an excellent working relationship with the Lough Ree Conservation Group, in harmonizing our interest of the waterways.

As stated last year, the attendance at our monthly meetings are still dismally low. We cannot put your views forward or make Policies without your voice.

#### **Developments**

With the Celtic Tiger well up and ROARING we should be very vigilant that it does not impede our waterways by over development in certain areas. I feel that there is plenty of scope for good and well planned developments, e.g. the east shore of Lough Ree is void of any good harbour.

The Athlone Chamber of Commerce commissioned a study on a future development plan for the Lough Ree Area in 97, to date the environmental side of this study has just been completed, this now has to be integrated into the overall strategy. I have been informed that this study will be completed by years end.

#### Consultative document on the Future of Ireland's Inland Waterways.

The Heritage Council requested a response from IWAI to a consultative document on the future of Ireland's Inland Waterways. At a meeting of the Council of IWAI it was agreed that the Heritage Council had correctly analysed the situation and identified the right issues. Mr. Colin Becker Vice President compiled a response on behalf of the IWAI. Correlating these two documents I feel that we now have a bases for a Policy Working document for the IWAI on Inland Waterways.

#### **Pump out stations**

This situation has not changed since last year, and I do not invisage any improvement in the coming year, however we will persist in requesting Local Co. Co. to upgrade the present infrastructure.

#### Safety

Water related sports has over the years always clamed its victims, and again this year. We, as a body, will have to improve our safety standards, before they are imposed upon us. We need to encourage the use of personal buoyancy aids. Rally organizers will have to insist on the wearing them.

The Celtic tiger has shown it's face on our waterways with a influx of boats and in particular jet skis and power boats, consequently the Department of Marine and Natural Resources have issued a notice to users of (jet Skis) and other fast recreational power craft. This is a **DO**, **DON'T**, document, it will be issued with your next aerial. It is recommended that a copy be kept on board in case of confrontation. The IWAI as a body should be aware of the dangers of speed in confined waters.

#### ISA/IWAI SCHEME.

I'm pleased to inform you that the ISA/IWAI training and certification scheme for boat handlers for all types of craft is well up and running. This is the culmination of perseverance and hard work, I would like to congratulate Stuart Mc'Namara on his achievements. I would recommend that every one undergo this training course and get their certificate. I feel that someday it will be compulsory

### Harbour Hoggers.

I have been informed that there was increase of 400 boats onto the Shannon river system this year, where are all the beats or moorings of them, unfortunately this has increased the number of HARBOUR HOGGERS. This problem is getting out of hand and we a body should advise others to restrain from this practice.

### ROYAL CANAL FUND RAISING,.

Over the past few years this Athlone Br. under the guidance of Damien Delaney have very successfully organized fund raising nights in aid of the Royal Canal Restoration Fund, I wish to thank the ladies, and some men who put their culinary skill into practice that helped make these nights very successful. I and on your behalf wish to thank sincerely all the sponsors too numerous to name right now, that gave very generously, and without their generosity, these fund raising nights would not have been as successful. What may is say about the wonderfully talented and charismatic members of our Br. The Royal Canal Band as they are aptly named Billy Henshaw Michael Martin Joe Lacken Larry Benson and other artist, who have through their

charisma and charm delighted us and ensured that the fans would appear. We owe them a debt of gratitude. We look forward to your support at all future events.

- C. Agree to the following members Mr. Liam Darcey President IWAI Mr. Damien Delaney Mr. Michael Martin of IWAI to fill the appointments as the original trustees of the Dunrovin Trust.
- D. Agree that Dunrovin remains as it is i.e. the Property, Main House and Grounds be rented. The PAD used as a meeting house on dates as directed by the executive for at least 3 years and not more that 5 years and a further plan be implemented thereafter

#### Result of the vote was 23 for nil against

Deed of Trust, and the results of the Branch decisions were put to the Council for ratification. This was approved and the President congratulated the Br. on their decision.

The expenses that the Br. have incured at present is £ 590. There may be further expenses during the signing over of the property.

#### Conclusion.


The foregoing is just a part of the workload the various committees get through. We are constantly seeking assistance and if you feel that you can contribute please don't be shy.

#### **Ye Iron Lung Crew Overrun**

Fresh from their triumphs at the North Shannon Rally, the Lung crew broke new ground (or water) at the end of August 1998, in joining the Sail Training Ship "Mir" when the Tall Ships Race reached Dublin.

What a time we had for the following 8 days!

Many IWAI members will have visited the Liffey quays over that never-to-be-forgotten weekend, when more than a hundred awesome craft lined the quays from Mat Talbot Bridge to the East Link, in some parts rafted out five abreast, Dublin looked eighteenth century again, a forest of masts, dinghies buzzing around, thousands of people promenading.

The intrepid Athlone ditch-crawlers joined the Mir on Monday night, resplendent in their red-and-blue striped jerseys, instantly distinguishable from the 'suits' who were attending a Dublin Chamber of Commerce Function on board. Among the motley crew were Sean Fitz, Tommy and Bernadette Henshaw, Johnny and Nora McGonigal, Sainnbhe Hoare, Brendan Thompson, Timmy and Ashley Donohue, Pat O'Meara and Jim Murray, along with fellow trainees from Cork, UK and Germany.

The Tuesday morning parade of Sail into Dublin Bay was headed by the doyen of the Irish contingent, Asgard 11, escorted by L.E. Ashling. How proud she must have been to show the way to such as the Libertad, Kruzenshtern, Sedov and the Mexican Cuachtemoe, which had received the Premier Award for it's crew's contribution to the whole Falmouth-Lisbon-Vigo-Dublin trip.

We were three days at sea, heading down the East coast, round Land's End and reaching Portsmouth late Thursday. During the voyage, we 'trainees' had specific duties, serving a couple of meals, helping with the bewildering array of ropes to rearrange sails, and doing four-hour watches. Your scribe had the graveyard watch (0400 to 0800). It was just gobsmaking on deck at 3am., no land in sight and a myriad of stars at every point in the firmament.

There was a resident Russian crew plus about fifty cadets from the Merchant Naval Academy in St. Petersburg. The cadets could speak some English. They all received one U.S. Dollar a day and were pretty impoverished. However it was slightly better than being paid in roubles!

#### **Russian Tall Ship**

We were accommodated in kubriks (cabins) of twelve bunks. Food was fairly basic but welcome when you had nothing else. We had a makeshift bar below decks - don't ask ... we drank them dry - and some mighty singsongs.

A lot of the Lung crew (led by the skipper) climbed the mainmast by rope-ladder. Others of us didn't even think of it, being subject to vertigo when standing on a chair to change a light bulb.

Whilst the trip was no luxury cruise, when the weather turned sunny as we neared the English coast, there was some sun-bathing on the aft deck. A million photos were taken, a thousand conversations had; we'd like the whole thing to have gone on longer.

On disembarking in Portsmouth on the Friday morning, we received passes to the four-day International Festival of the Sea. This huge event took place in the 300 acre Navel Dockyard. Apart from many of the Tall Ships from Dublin, we could tour historic ships like Nelson's HMS Victory, modern aircraft carriers and submarines.

There were four separate stages around the site, featuring a vast range of music from morning till late. Each night finished with a stupendous fireworks display.

Happily, we were able to continue using the Mir and Kruzenshtern as our base for the duration of the festival. How well they looked against the background of the harbour, filled as it was with private yachts and cruisers of every size - down to a four-foot wide coracle.

As I said at the start, what an eight days. Still an' all, I'd swop the lot for Blackbrink Bay anytime....

## Regeneration officer for the Grand Canal?


We must admit that due to the branch's involvement with fund-raising for the Royal canal we have been a little lax in our attention to the Grand Canal what's new is always more eye-catching! However a recent article in the Westmeath Independent caught our Under eye. the heading "Another Boost for Offaly Tourism" it seems that the people of Offaly and Kildare have formed the Grand Canal Liaison Group this group announced the appointment of a regeneration officer.

The group is composed of the Kildare and Offaly Co.Cos; Ducas, the Waterways Service; Offaly and Kildare Leader 11; Action South Kildare and OAK Partnership.

The regeneration officer will be responsible for promoting the use of the educational, canal for recreational and tourism pursuits and will work with all sections of the local community. Small projects will undertaken this year at Daingan and Edenderry in Offaly and at Rathangan, Athy and Monasterevan in Kildare. It is hoped this new appointment will assist in the future development of both the Grand Canal and the Barrow Navigation.

This group was formed because οf the Shipman and Martin Report and was launched in the summer of 1998 by Minister of Arts, Heritage, Gealtacht and the islands, Sile de Valera.

We wish this group every success, and that local communities along this canal will, by their involvement, ensure the continued viability of the canal.

#### **Wet Bikes**

These craft are causing considerable controversy among users of inland waterways - our area of interest - and also at seaside resorts.

On the one hand the users craft of these think heaven has come, especially if the age of the user is very young, like 10 years, I know if I was that age Ι would certainly love to have been able to use one of these craft. And maybe I would have used it well and sensibly, away from other people, aware of safety of myself and others - - I think not!

There is no doubt that these craft give great

pleasure to users, of increase speed numbers is a witness fact, this and also unfortunately, the nuisance caused by uncontrolled behaviour is widespread craft.

As usual, getting governmental authority to take an interest in this growing problem is only now happening, both here and across the water in the UK

Here Minister Michael Woods, of the Marine and Natural Resources has issued a code of conduct for users of Wet Bikes and other fast recreational power craft.

However, neither licensing age of users is mentioned. Nor ĺS the necessity for proper instruction in the use of power fast craft mentioned.

Why do authorities take such a long time to realise that eventually these problems have to be addressed?

We in the I.W.A.I. are not against the use of Fast Recreational Power Craft, but we are for Safety, Responsibility, Care for others, Care for ourselves and the environment we share.

#### New VHF Licence

"The Global Maritime Distress and Safety System (GMDSS) is being implemented presently and is compulsory for vessels which are required to comply with the provisions of the International Maritime Organisation (IMO) Safety of life at sea (SOLAS) Convention.

Recognising the need for non SOLAS vessels, such as pleasure craft and certain fishing vessels which are not required to comply with any International agreements, to take part in the GMDSS to enhance the safety of those vessels and to enable those vessels install the necessary radiocommunication and radio life-saving equipment, it is necessary to revise the Radio Operator Examination Syllabi."

The changes in the regulations are being implemented in coastal and international waters during this year, and it is likely that they will also apply to inland waterways later this year.

Put simply, the technology available, and in use, is getting more and more sophisticated, consequently the syllabus for the Operators Certificate is being updated to cover the advances in the technology and the associated regulations governing their use.

A new range of certificates is introduced to cover the full range of systems in use. So how will this affect people who already have the Restricted Certificate of Competency in Radiotelephony VHF only (VHF operators licence), I hear you ask. ?? – Very little, your current operators licence is still valid, unless you have occasion to: -

- (a) operate the new technology such as Digital Selective Calling equipment (channel 70 replaces channel 16 as the emergency channel); Emergency Position Indicating Radio Beacon (EPIRB); Search and Rescue Radar Transponder (SART); Maritime Safety Information system (Navtex); or
- (b) Install and operate any of the above equipment on your vessel. In either case you will need to upgrade your current operators licence, and in the case of (b) you will also need to upgrade your "Ships Licence".

The new certificate for VHF operators is called the Radio Operators Short Range Certificate (SRC) and the syllabus consists of two modules which may be taken separately or as a combined examination.

Module 1 (Only), is an updated version of the current licence, and is in three parts: -

- (A) Rules and Regulations governing the exchange of marine radiocommunications, and Distress, Urgency, and Safety procedures, using VHF.
- (B) Radio communications, candidate demonstrates ability to send and receive messages using correct procedures on VHF.
- (C) Operational Performance Test using VHF equipment, EPIRB, SART, and Radio Battery set up.

Module 2 (Only), is an oral and practical examination to demonstrate the candidates ability to operate Digital Selective Calling equipment (DSC); EPIRB; SART; Navtex; Radio Battery:

- Candidates who pass the examination for Module 1 (Only) will be awarded a Restricted Certificate of Competency in Radiotelephony (VHF Only). (The new equivalent of the current licence)
- Candidates who pass the examination for Modules 1 and 2 will be awarded the Short Range
  Certificate (SRC) of Competency in Radiotelephony. (The new updated licence to operate the new
  technology)
- Candidates who already hold a Restricted Certificate of Competency in Radiotelephony (VHF Only), i.e. the current licence, who wish to upgrade to the Short Range Certificate, will be examined in the sections relating to the GMDSS in parts A,B,C of Module 1 in conjunction with the examination for Module 2 (Only), and on passing, will be awarded the Short Range Certificate (SRC) of Competency in Radiotelephony.

Course Providers are also required to upgrade their qualifications and facilities, which must be approved by the Director of Telecommunications Regulation, and this may have implications for the availability of courses in the future, due to the capital cost of the facilities required. There is no need to panic yet, your existing VHF set will still work, channel 16 will still be monitored, until there is a total changeover to GMDSS. We will keep you informed of developments.

Whatever the "reasons/rumours", surely this very important site, both from the point of view of Athlone town and of the River Shannon, should be dealt with in a professional and speedy way by our town councillors and planners.

It certainly may not be a fault of the Urban District Council that the site has ended up like this but maybe a lesson could be learned from whatever caused the hold-up in the development.

If, for instance, like travel agents have to have a bond which covers their clients from loss if they go out of business, a council could ask a developer to carry a bond which would enable an uncompleted site to be restored in an acceptable way, even if the developer

concerned could not complete the work.

We wish the Athlone Urban District Council every success in finding a suitable development for this site as soon as possible; and may we ask that such development be in harmony with both the River Shannon and the town.

#### Jet Ski Users

In July 1998 the Minister for the Marine and Natural Resources, Dr. Ml Woods, T.D. launched an 11 point safety code for users of jet-skies and other fast recreational craft. Under the code Users of the craft are advised to keep at a safe distance from other water users and not to operate at unsafe high speeds, not to drink and drive or to create unnecessary noise or disturbance.

The following are the 11 points of the code:-

#### Do

Keep a safe distance from other water users and do not endanger their lives.

Learn how to operate your machine

Know your own and your machine's capabilities and limitations.

Wear an approved and suitable lifejacket or buoyancy aid.

Check weather forecast and tides

Have a suitable means of attracting attention in an emergency.

Advise a person ashore of your expected departure and return times.

#### Don't

Operate your machine in the vicinity of other water users e.g., swimmers, divers, craft such as angling boats, canoes, sailing boats, etc.

Cause a safety hazard by high speed use

Create unnecessary noise and disturbance to other people or wildlife

Drink and drive

We all hope a code of practice will be sufficient - it's up to you who love these craft to prevent a code becoming a law.

#### Royal Canal

The Royal Canal Amenity Group was founded in April 1974 and is a voluntary restoration group dedicated to the restoration of the Royal Canal and the provision of canal related amenities.

In August this year the R.C.A.G. celebrate their 25<sup>th</sup> Anniversary and their success to date by running a rally on the restored section of the Royal Canal from Castleknock in Dublin to Abbeyshrule in County Longford.

It has been a long and frustrating journey to have this 60 mile section canal restored, and while the success to date must be applauded, the remaining 20 mile section could prove even more frustrating in the absence of sufficient funding and the political will to see the project through to it's completion.

The remaining unrestored section is all in County Longford, and the main obstacle to be overcome involves raising 8 road bridges to allow for navigation clearance along the canal. Estimates vary from £10 million to £15 million, depending on the source, and the debate as to whether the money should be provided from structural funds via Duchas or via the National Roads Authority, drags on. Either way, a ministerial decision is required, and soon, in addition to a political will in County Longford, from both Councillors and County Council Executives to have the roadworks started without delay.

The Local and European elections in June could be your opportunity to influence the politicians towards making the right decisions, so don't be shy when they come canvassing for your vote.

Much is to be gained in Co. Longford from the full restoration of the Royal Canal from the added angling, walking, boating, and general recreational tourism spin-off. Restoration of the Clondra to Longford town section could bring an immediate tourism boost as an additional stopping off point for Shannon boating traffic.

While the Royal Canal communities living along the restored sections can bask in the fruits of their success as they watch the boats go by, and benefit from the angling and boating tourism which has developed, we must spare a thought for the communities who are still waiting patiently to see measurable progress along the unrestored section. You can imagine how difficult it must be for them to keep a level of interest alive in these local communities in the absence of visible evidence of progress, or even to have water in the canal, and still they persevere, buoyed by the support they receive from Athlone Branch IWAI from the proceeds of the sales of Green and Silver, and from the Royal Canal Band and their supporters, whose tremendous voluntary contributions through their music night fundraisers over the years have provided much needed funds and a social uplift to otherwise sagging spirits.

The IWAI have placed the restoration of the Royal Canal at the top of their priority list with Duchas and the Minister for Arts, Culture and the Gaeltacht, and Athlone branch will be actively promoting the project at whatever occasion presents itself. We need your support and you now have an ideal opportunity with the elections in June to extract a commitment from your local politician to use his/her good offices to persuade the relevant ministers to provide the funds and the resources to finally complete this restoration project.

#### **ROYAL CANAL RALLY - 1999**

"Well what can I say?" to quote Chairman Noel Spaine, about the 25th Anniversary Royal Canal Rally. Words like euphoria, and jubilation spring to mind to describe the welcome the rally received everywhere along the route from the 12th lock at Castleknock to Abbeyshrule. While there was a total entry of 27 boats, a core fleet of 19 boats completed the full distance, led by Commodore Allen O'Leary, the remainder joined in for shorter trips along the route.

The fleet consisted of 4 Leisureways Holiday canal boats, 1 private Narrow boat, a variety of private cruisers and 9 Wilderness boats, brought over from England by the Wilderness Boat Owners group, who promote and support waterway restoration projects throughout the UK. It took the Wilderness group a while to figure us out, with all this hospitality, entertainment and sing along sessions, but they are fast learners, and by the time we reached Enfield, Noel had taught them the words of "The Auld Triangle", which was performed at every opportunity and they joined in with such gusto that they became the life and soul of the rally for the remainder of the journey to Abbeyshrule.

The aqueduct carrying the canal across the M50 provided the stage for the photocall at the opening ceremony, and some light hearted relief for the frustrated motorists above and below. John Martin of Ducas cut the ribbon and assured us that full restoration of the Royal was high on the Minister's list.

Maynooth was our next stopover, a warm welcome at their fine harbour, entertainment in the GAA Club, and a tour of the University before moving on to Enfield on Tuesday.

Enfield left us breathless, - the huge crowd that greeted us at the harbour in the beautifully landscaped amenity park; the band, the marquee and the carnival atmosphere; the Eclipse Pageant and the Celtic Fancy Dress which carried the theme through to the traditional Irish Night in the Bridge House. Wednesday morning we had the Eclipse, a computerised view in the marquee, a televised view, and as if by

magic, the sky cleared and we had a live view for those with the special glasses. Later, two trees were planted in the amenity park, one to the memory of Brigid Pender who was deeply involved in community developments in Enfield, and the other to the memory of Eddie Slane. Those of us who worked with Eddie on the Royal spoke our tributes, but the most poignant tribute by far was paid by Eddic's grand-daughter, Gemma (aged 6)who, in a few simple works, urged us to be happy and shed no tears. Nobody spoke after that, we were all too overcome by the emotion of the moment. What a great pity that Eddie couldn't have lived to join us on this rally to celebrate the completion of this phase in the Royal restoration history.

From Enfield we backtracked to Kilcock where the Wilderness group gave us a magical illuminated display with their boats. Each boat was decorated with arrays of Christmas fairy lights arranged in various designs and flashing sequences. The boats literally waltzed around the harbour, delighting the crowd surrounding the harbour. Since being bypassed, Kilcock has made great progress in becoming a very pretty village, with a fine harbour, well maintained banks, and cobblelock paving. What a pity if this was spoiled by allowing the proposed incinerator to be built so near the village and the canal.

## "Cruisers Covered in Dust from Plant"

The above headline appeared in the Topic Newspaper on 12th August 1999 and the article stated - "A number of cruises were covered with emissions from the Masonite plant when there was an accident at the plant. Up to 20 boats moored overnight near Albert Lock were covered with wood dust and 10 cars parked nearby were also coated with the dust."

The article went on to state "There have been problems with objectionable smells from the plant and emissions of formaldehyde but these have been rectified."

We are aware that the E.P.A. is keeping a close eye on this plant, what a pity such a good employer had to place their manufacturing plant in such a sensitive place.

### New Marina for Lough Ree.

Ms. Sile de Valera, Minister for Arts Culture and the Gealteach, has applied to Roscommon Co. Co. to build a new £800,000 marina at Ballyleague on Lough Ree. Ballyleague is the west part of Lanesboro, and from the view of a boat going upstream, is a dull shore on the left hand side just before the lake becomes the river again. It is to have 32 berths and if permission is given soon, the project could be completed by 2001.

Ducas' Waterways service took the decision to go ahead with this marina as it was found that the existing facilities could not cope with the increased number of tourists.

The lake bed will be dredged to 35.3m and a fixed breakwater projecting 100m into the lake will be constructed along the western edge

of the marina. A floating breakwater will be built for the southern edge.

The moorings will be floating moorings on guide piles with access ramps to the shore.

There will be a 1.4m high wave wall on the fixed breakwater.

A very welcome announcement, we certainly need another marina on Lough Ree, and wouldn't it be great if Glasson could be the next Lough Ree development!!

#### The Law and Water Safety

In a recent article in the Irish Times it was reported that the Minister of the Marine has established an new department to deal with regulations regarding water safety among pleasure craft.

Where laws regarding safety in the use of fast craft like speed boats and jet skies is welcomed by most of us, especially where their use by untrained and underaged people is concerned, we hope that whatever laws are deemed necessary to be enacted for ours and the environment's safety, that these laws will not interfere with the safe and free enjoyment of our inland waterways or make access to these enjoyments only available to the well-off.

At present the Greek Supreme Court is considering a total ban on wet bikes.

Cyprus is considering a law which will introduce zoning to keep wet bikes away from bathers and other water users and in Spain there will be a 200m wet bike exclusion zone around all beaches, and wet bike owners will be

required to register their bikes with the relevant port authorities and that they will be properly insured.

The greatest cause of death and injury is speed in the hands of untrained and immature people, and we hope that any laws which are made in this country are made specifically to control only those vessels and their owners and not interfere in an unnecessary way with craft which are already subject to registration and which are not in themselves lethal dangers to others.

### Royal Canal Rally 1999. by Damien Delaney

Across the Blackwater Aqueduct to Fureys of Moyvalley which produced the best sing-along of the rally, with Jim Murray and Sean Fitz in full flight, and the Wilderness group becoming "more Irish than the Irish themselves".

Longwood greeted us with a lunchtime reception and ceremonial anointing of all the skippers, while granting them the right to cross the Boyne and through that region without fear of molestation, pillage or plunder. Hill-of-Down looked splendid, and again crowds turned up to greet us and tell us how great it was to see boats on the canal again. Then on to the harbour to music and formal greetings, and the crowd got bigger. By popular request the Wilderness group repeated their illuminated boats display at 10p.m. to a packed and very appreciative audience.

Monday we did a coach tour of Longford, Keenagh, Clondra, and Ballymahon to show our visitors what remains to be done to fully restore the Royal, and to meet the unsung heroes who still toil and sweat and wait for the water to reach them, all because successive administrations have failed to get on with the. job of replacing the culverts with proper bridges with navigable headroom.

Ballynacargy and the crowds waited patiently, despite the impending thunder storm, while the boats formed in line astern before entering the harbour, to allow pride of place to local heroes Watson Mills and Tom Shanley. As if by magic or divine intervention the storm moved away and the sun shone again as the fleet arrived. Food was laid on in the community hall for everyone on arrival; free barbecues and music in every pub; music and dancing in the village square and an atmosphere of excitement that one would only expect on winning the All Ireland. Again, by popular request, the

Wilderness group gave their illuminated display much to the delight of the huge crowd that surrounded the harbour.


Abbeyshrule, and again the impending thunder storm moved away allowing Gabriel McGoey and Co. to lead the fleet to the sunny reception at Abbeyshrule Airport. Tea and cake and an aerobatics display, followed by more music on the canal bank, before moving on to the end of the line, — for the time being! The boats approaching the culvert were like horses sizing up the fences before a race, the great pity being that this is all that prevents us reaching Ballymahon, what progress that would be.

The closing Dinner and compliments to all concerned - to Commodore Allen O'Leary, Committee Noel Spaine, Padraig O'Brolchain, John Bowler and many others who along the way, to all the RCAG branches who entertained us "Royally" throughout the rally, to FloGas, the main sponsor and to the many other sponsors, to Duchas and the staff of Waterways Service who manned the locks and gave support all the way, to our own Royal Canal Band of Billy Snr., Billy Jnr., and David Henshaw, Larry Benson, Michael Martin, Joe Lacken and Frank Reid, who had them singing and dancing in the aisles as they have been doing without charge, for longer then I care to remember.

Overall reflection - the canal is in very good condition, and travels through beautiful countryside. Some slight weed problems between Confey and Castleknock, and between Ballinea and Coolnahay, and two isolated obstacles near Enfield Station, all of which could easily be remedied. Some mindless individual ran off the water in the level below the 36th lock, but the Waterways staff were on hand and solved the problem quickly with no disruption to the rally.

Now that the rally is over, what does the Royal need to sustain the momentum that has been generated. Boats need to be visible in the towns and villages along the canal and suggestions that more hire fleet, more private boats, Flotel boat supported by minibus to cover a wider corridor deserve consideration and support. What can we do to help? More activity on this stretch strengthens the case to complete the restoration to the Shannon. This was a brilliant rally which will be impossible to repeat, but already plans are being prepared for next year which may consist of a number of smaller rallies, so watch this space for details. It's well worth a visit just to see the tremendous work which has been done by the voluntary groups along the route. Well, What More Can I Say!!!

## Millennium Fountain for Athlone?

#### Lough Derg & Lough Ree Catchment Monitoring and Management System.

**Management Proposals**;

#### Sewage Discharges

- Ensure compliance with the requirements of the EU Urban Waste Water Treatment Directive (91/271/EEC):
- Provide Phosphorous reduction facilities at Wastewater Treatment plants of less than the population equivalent threshold specified by the Directives at locations where sewage discharges significantly contributes to the eutrophication of rivers or lakes.

#### **Industrial Discharges**

- Review licence conditions for industries whose discharges contribute to the eutrophication of rivers or lakes, or otherwise impinge upon the relevant quality objectives of the receiving waters;
- For those industries, specify measures to upgrade waste treatment facilities and/or reduce Phosphorus inputs at source.

#### **Nutrient Losses from Agriculture**

Measure 1 Storage and Management of Wastes.

- Make Bye-Laws under the Water Pollution Acts requiring;
- adequate manure storage capacity for animals housed during the winter period. Guidance in relation to slurry storage requirements is available in the "Code of Good Agricultural Practices" published by the Department of the Environment and the Department of Agriculture, Food and Forestry (1996). It is likely that a minimum of 20 weeks storage capacity will be required for farms within priority risk areas. Local Authorities may decide to accept less than 20 weeks storage capacity in situations where farmers can demonstrate a lesser requirement through the preparation of an approved Nutrient Management Plan:
- the minimisation of farmyard wastes by the separation and control of extraneous water;
- that in a normal year, at least half the manure produced during the winter housing period is landspread by 1 July and the remainder by 30 September;
- Provision to be made for the phased compliance with the requirements for slurry storage (3 years maximum while working to a local authority approved plan);
- Apply to extensive agricultural risk areas.

#### Measure 2 Areas of Excess Soil Fertility.

- Make Bye-law under the Water Pollution Acts requiring:
- mandatory nutrient management planning and adherence to current Phosphorus guidelines (Teasgasc 1998);
- Apply to extensive agricultural risk areas where available indicators suggest excessive soil fertility.

#### Measure 3 Intensive Agricultural Enterprises (IAE's)

- Serve notice under the Water Pollution Acts requiring:
- 'existing' pig installations exceeding 1,000 units on gley soils and 3,000 units on other soils and 'existing' poultry units exceeding 100,000 units not currently subject to IPC licensing, to prepare a Nutrient Management Plan (NMP);
- Make Bye-law under the Water Pollution Acts requiring:
- that landowners not accept waste from Intensive Agricultural Enterprises except in accordance with a Local Authority or EPA approved NMP;

Measure 5 Rural Environment Protection Scheme (REPS)

Actively promote the uptake of REPS throughout the catchment.

#### Stolen

#### Athlone News

As mentioned in our last Aerial we were delighted to say that work had begun on the old Silverlee site on the banks of the Shannon above the road bridge in Athlone.

We, along with most of the people in Athlone, are delighted that the remaining large derelict site, that of the old Ritz cinema is in the process of being demolished to make room for a development of a pub, restaurant, retail units and upmarket apartments and penthouses costing £2.5m. This development has been designed by a local architect, Angelo Magliocco's firm Creative Design.

The main mover behind this development is a Loughrea business man, who was best known for his association with "Mother Hubbard" on the main Dublin/Galway road near Enfield.

It is hard to believe that the Ritz Cinema was designed by the late Michael Scott, who was one Ireland's best known architects, who also designed Busarus in Dublin. The Ritz building was never completed and after it ceased being a cinema, it had been used as an amusement arcade and some alterations were made to the front of the building which certainly did nothing to enhance the property.

There is also going to be proper development of Burgess Park, which has been let get a very neglected air about it. Local residents have got together to get the park properly maintained and patrolled, so that cider parties and other unsociable behaviour is ended and tourist and

locals can once again enjoy walks along the banks of the Shannon.

Athlone Sub-Aqua Club.

The local Sub-aqua Club is starting the building of their new club house in the Wansboro field on the banks of the Shannon beside the Jolly Mariner. The turning of the sod was performed by Minister Mary O'Rourke, T.D.

This Club was founded in 1972 and has trained more than 500 divers and saved many lives in that time.

Mrs. O'Rourke told Mr. Jim Campbell, Chairman of the Sub-Aqua Club, that the work done by his life-saving team was of enormous benefit to the local community... "It is in the truest sense, a noble and worthwhile commitment". We of the Athlone Branch, IWAI would certainly echo these sentiments.

Planning permission has been sought by Heavey Architects, Athone for a development of houses on the meadows below the lock on the west bank. Hope the builders are good swimmers!

And we know what our wishes are for the new year! A clean Lough Ree, where we can once again swim to our heart's content, and an operating pumpout station in Athlone - Lord, our cup will really run over!

Even better is the recent announcement that all school children must be taught to swim before they are adults and that is the best solution to the many fatalities which could have been easily avoided if the person had been able to swim. Knowing how to swim still does not negate the necessity of wearing a life jacket all the time. Even adults!!!



### **Pollution**

Will we ever get away from this awful word, it seems not. Reading a foreign newspaper, we came across the following-Plastic balls coated with bacteria could be the key to cleaning up waterways polluted by dyes. We are not aware of dyes being dumped into our waterways at present, but if it can be dumped, no doubt it will or is being dumped in this ecologically unfriendly country of ours.

The solution which scientists at Leeds University have come up with is bacterium found in rivers which will in a few hours change a flask full of red dye into colourless water.

### Boyle & Lough Key Forest Park

Last summer a couple of people visited Lough Key Forest Park, and were most disappointed with the condition of the Fairy Bridge. In fairness bridge was OK but it was almost lost in the huge amount of growth of the surrounding trees, which obviously thrived in the cool wet soil of the canal which the bridge crossed. Years ago that bridge was really fairy-like with the full sun shining on and through the beautiful river sculpted rocks which decorate the bridge.

All is not lost as the people of Boyle have raised their collective voice in complaint that Boyle has been left behind in the development stakes and are demanding big improvements in the town and forest park.

Coilite is taking over the management of the Park, and plans for the future development have been submitted to Coilite by Roscommon and the local people. Some of the things which need upgrading to modern expectations, like visitor centre, bar, restaurant, first class accommodation and varied sport facilities on land and water.

All the walks have become overgrown and dark, the buildings in use at present are from the 1970's and look very well worn-out.

The caravan and camping sites will be upgraded, 20 chalets will be built and designed to fit in with the natural surrounding, and a hostel catering for families and independent travellers will be developed at the existing stable buildings.

The stone stables, with cobbled courtyard will house leisure facilities, shower and changing rooms, and a regional Coillte office. The cafe will be developed into a visitor centre with restaurant and bar and will also house information on forestry and the environment.

Tennis courts, walking trails, and orienteering course, mountain bike trails and barbecue sites will be developed.

Unfortunately, the ugly Moylurg tower would be too costly to demolish. Maybe with de-commissioning, a bit of free samtex could be donated as a gesture of good will!

The ideas put forward by Roscommon Co.Co. and local interests were included in the plans drawn up by Duncan Steward, of "Our House" fame, which will allow for the integrated development of the park and will cost in the region of £5m.

For all this work to commence, Coillte is looking to Bord Failte for the funding, and if it come through, work would commence in 2000.

An action which will bring the lake to Boyle is the building of a new canal, the first new canal to be built in Ireland for 200 years, which should be completed by next year. This work is being undertaken by the Shannon Navigation Team in the Department of Arts and Heritage. The canal will arrive into a newly constructed 50 berth harbour located just outside the town, making it easier for water based visitors to see the town of Boyle and the marvellously restored King House and the Boyle Abbey ruins.

This is all very welcome news, as Lough Key is nearly always at the top of the list of favourite places on the Shannon/Boyle rivers.
